1. Always check the motor vehicle registers for liens - Go to [www.brreg.no](http://www.brreg.no).
2. Check the vehicle's history. by contacting the Norwegian Public Roads Administration (Statens vegvesen), Send text to 2282, where you enter "REGNR" before your registration number:  
REGNR AA00000 or call 06650.
3. Check if passed the last EU inspection and the deadline for the next EU inspection at [www.vegvesen.no](http://www.vegvesen.no).
4. Test drive the van before purchasing it
5. If possible, get the car checked by a mechanic or testing station before buying.
6. The agreement must be printed out and signed by both parties.
